PRESIDENT'S REPORT SEPTEMBER 26, 2015

The executive has been pleased with its progress during this 2015 tennis season during which we achieved several goals that enable the members to continue enjoying the game they love.

- 1. Courts were cleaned early in the season and lighting was improved by over 50% making the courts better to play on. Both of these improvements were low in cost, enabling us to keep more funds in our bank account.
- 2. An additional team was added to the club at the B level.
- 3. A house league was started and enjoyed success with our male members; perhaps next year the women will join in as well!
- 4. We hosted an event with Wilson to try out their new racket, and several members were videotaped so that they could learn more about their strokes and speed of serve.
- 5. Membership was up by 10% to 255 in total, and revenue by 17%. Adult membership increased over Junior membership. These are all positive results for HFTC, that we will strive to maintain.

The weather was good most of the spring, summer and fall. This plus the new teams and extra use by new pro's led to increased activity on the courts. We believe that this is also a positive for our club.

We did not make other significant progress towards our goal of resurfacing the courts in the near future but the City of Toronto did make some repairs to Court One. We have been told that we will have to wait an additional five years before the City will undertake resurfacing at our club.

ICTA Teams: All enjoyed the competition. Thanks go to the captains, Konrad Chan, Ed Wilson, Jasmin Carleton and Kieran Kennedy.

NYTA: Our Men's Veteran Team and Junior Team, led by pro Ed Wilson, played on Saturday mornings and also provided some stiff competition to their opponents. The Junior Team benefitted by having new members join them.

Having the teams play kept the courts busy in the evenings but we also continued Drop-In tennis coordinated by Lorraine Gray as she has done for several years now. Carol Dunn assisted Lorraine this year with social activities.

The club benefited this year by having a large executive, enabling us to be more organized in administration and maintenance. There were six new members on our team and I want to thank all of them: Bernard Assouad, Jack Meyer, Lorraine Gray, Ed Wilson, Carol Dunn, Chantal and David Woods, Vijay Kandeth, Pierre Foucher, Heather Sinemma and Tanya Wilcox.

A special thank you to Heather and Tanya who coordinated our membership all year despite the challenges of fitting this activity into busy family lives, work and other volunteer commitments. Going forward to 2016 we are looking for assistance with membership tasks of maintaining the membership list, sending out shoe tags and reconciling payments. Please contact one of the executive to volunteer for this important task.

Thank you once again to Wayne Brown who worked with the neighbourhood schools to identify students who qualify for Jump Start Funding to become club members and take lessons. Our funding for this program increased in 2015.

And last but not least, our monitors, Greg and Avery, who've done a very good job taking care of the courts and clubhouse.
