President's report HENRY FARM TENNIS CLUB

Annual General Meeting October 20, 2018

I wish to welcome all of you who took time away from your busy life to attend the Club's Annual General Meeting.

I would like to start my report by thanking all the members of the Club Executive for their dedication and their commitment to the success of the Club this season. A Club like ours cannot exist, let alone survive and flourish, without the enthusiasm and loyalty of the volunteer members of the Executive. And I have to stress that these are <u>volunteers</u> who spend countless (and unpaid) personal hours to serve the Club and its members. So, heartfelt thanks to all of them.

Special thanks go to Jasmin Carleton, Member at Large, who is staying with Executive and who helped the Club enormously this season with her commitment to the Club's activities. Of particular note are the morning Kafee Klatsches and the two OTA tournaments at the end of the season. In recognition of her contributions to the Club, I wish to present her with the Bruce Childs Award from the OTA. Thank you, Jasmin.

Special thanks also go to our long-time Head-Pro, Ed Wilson. Ed has been a mainstay of the Club for a number of years and has become almost synonymous with the Club. Over the years, he has coached a large number of juniors; he has tirelessly contributed to the success of our Club. Similarly, in recognition of his contributions, I wish to present him as well with the Bruce Childs Award. Thank you, Ed.

Let me go now through my report. As is usually the case, the Club had its ups and downs, its successes and disappointments, so let me go through them at a high level.

I will start with the **Membership Report**. Membership has always been a challenge for us and is at the core of the financial sustainability of the Club. In 2018, we had 153 members in total, a decrease of 60 vs. 2017, a 26% decline. Adults were 125, just above the City minimum of 120 members. While the number of Henry Farm members remained relatively stable, the non-HF members dropped significantly. Another disappointment if the drop in Junior membership; I will attribute that to a change in offered junior programs that was not very successful.

Like last year, we continued to offer through our website the option to register and pay on-line; this continued to be quite popular with as much as 73% of the registrations were made on-line. Like last year, we offered an "early bird" discount, 5% this year. Combining the reduced membership with a bit higher membership fee, we generated 15% less membership income.

In summary, and as in previous years, we have our work cut out for us to increase membership. One of the big advantages that Henry Farm has over many other clubs is courts availability. We'll need to learn to play that card better.

I'll go now over the Club **Finances** (reverse side of the hand-out). On the basis of preliminary numbers (as we have not fully closed the books on the year), we generated a healthy surplus of almost \$2,600.

On the Operations revenue side, in addition to membership fees, we generated extra income through court rentals (Peter Nielsen and Bayview Glen school), through other programs such as the morning Kafee Klatsch and through a generous donation.

On the Operations expense side, monitor costs are our largest item, with a large increase vs. 2017 due to the increase in the provincial hourly minimum wage. Like last year, we made every effort to hire young people from the Henry Farm community. We had 4 community youngsters who did their best to keep the Club in top shape.

The biggest maintenance expense was the purchase of an air-conditioning unit in the Clubhouse that came in very handy throughout our very hot summer.

Permit fees to the City, association dues to the OTA and insurance premiums added up to almost \$5,100, in the same league as previous years. But still not cheap, and not negotiable.

Despite all that, "Operations" generated a net positive result.

"Lessons and coaching" revenues and expenses were lower than in 2017, because of the change in programs offered. Also, revenues flowed directly to the coaches. JumpStart revenues were zero, as the qualification requirements became more stringent a few parents were willing to divulge their family finances. This item generated a small surplus

The "Tournaments and special events" also ended with a small surplus. The Club hosted an MS350 OTA tournament and an U14 OTA tournament, both of which were quite successful and generated surpluses; thanks go to Jasmin and to the group of volunteer helpers who ran both events. Tennis Access cancelled their tournament this year. The Executive decided to continue with these tournaments next year, and to use them to more widely promote Henry Farm.

Bottom line, we added \$2600 to our reserve fund which stands now at just over \$28,000.

On the facilities side, we were quite happy that the City agreed to upgrade the bathrooms, the kitchen line, lighting and baseboard heating. Together with the City's upgrade, the Bunea family generously offered to renovate the main hall: new ceramic floor and paint, and a couch. You will agree with me that our Clubhouse looks now quite nice.

Ed Wilson will go in a few moments over the results of our participation in the many external leagues.

This year, we ran again our in-house league. Despite a few start-up hiccups, I believe it was quite successful and allowed many members to meet and play with new partners. We will make a few changes next year, on the basis of the feedback we received.

We also had a number of other in-house activities. Carol Dunn ran a beginners network on Tuesday evenings aimed primarily at the shy section of our membership (ladies...?). On Mondays and Wednesday mornings, Jasmin Carleton ran a Kaffee klatsch (basically a drop-in program with a heavy dose of socializing, fueled by Jasmin's delicious home-made muffins) which attracted a few players, members and non-members. I wish to thank Carol and Jasmin.

Similar to last year, members were given the option of booking a court on our website. This option is being increasingly used.

In conclusion, I wish to thank again the members of the Executive for their dedication. I wish everybody a pleasant and safe winter and I hope to see everybody back at the Club next year.

Thank you. I will now give the floor to our Head Pro, Ed Wilson who will cover our participation in external leagues. We will open the floor to questions after his report.
